If I am driving a car and not arriving by taxi, I will receive a ticket with a parking time countdown at the entrance. It is important to keep this ticket

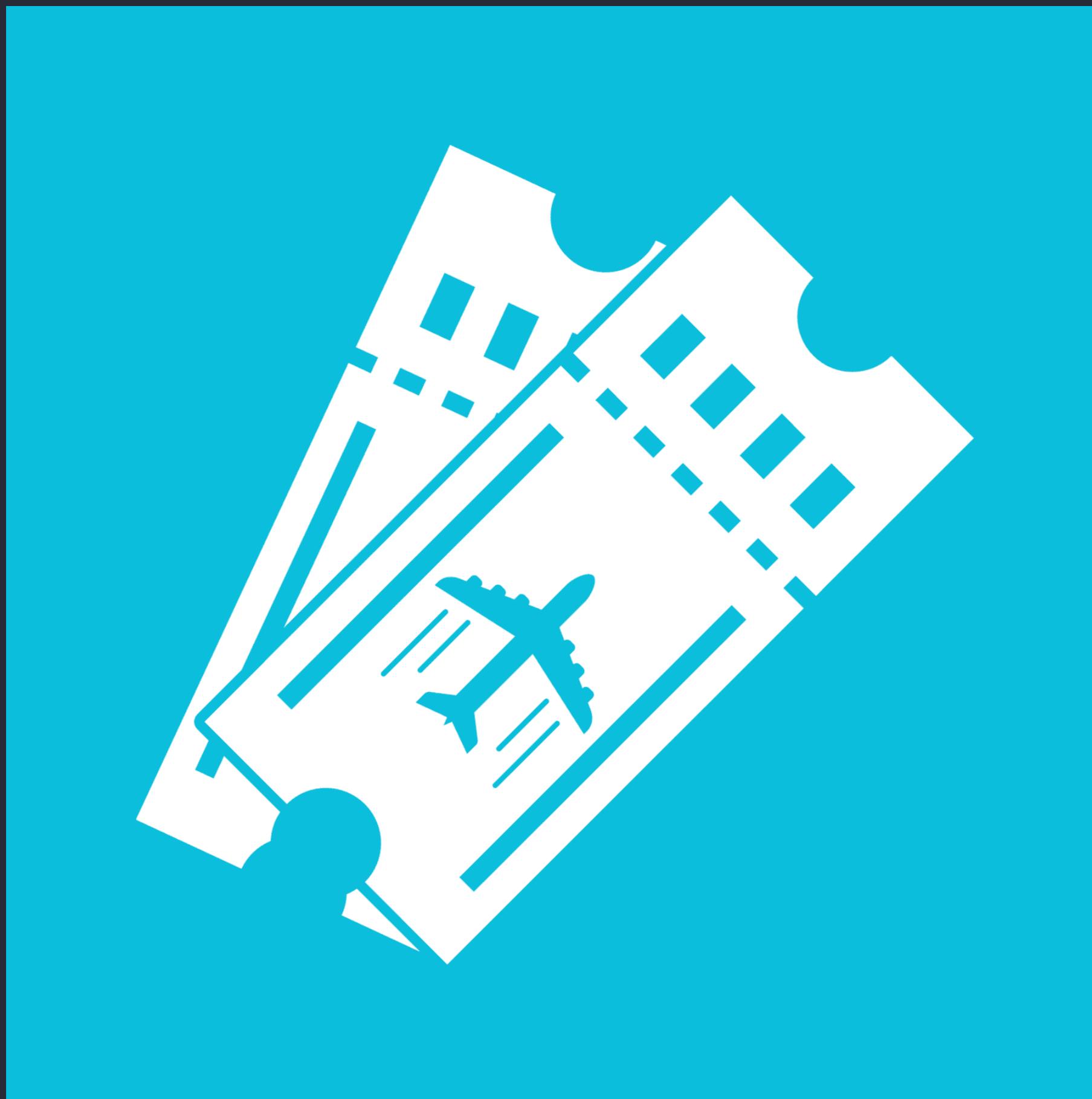
I will pay for parking when I take my car back

The doors are opening automatically

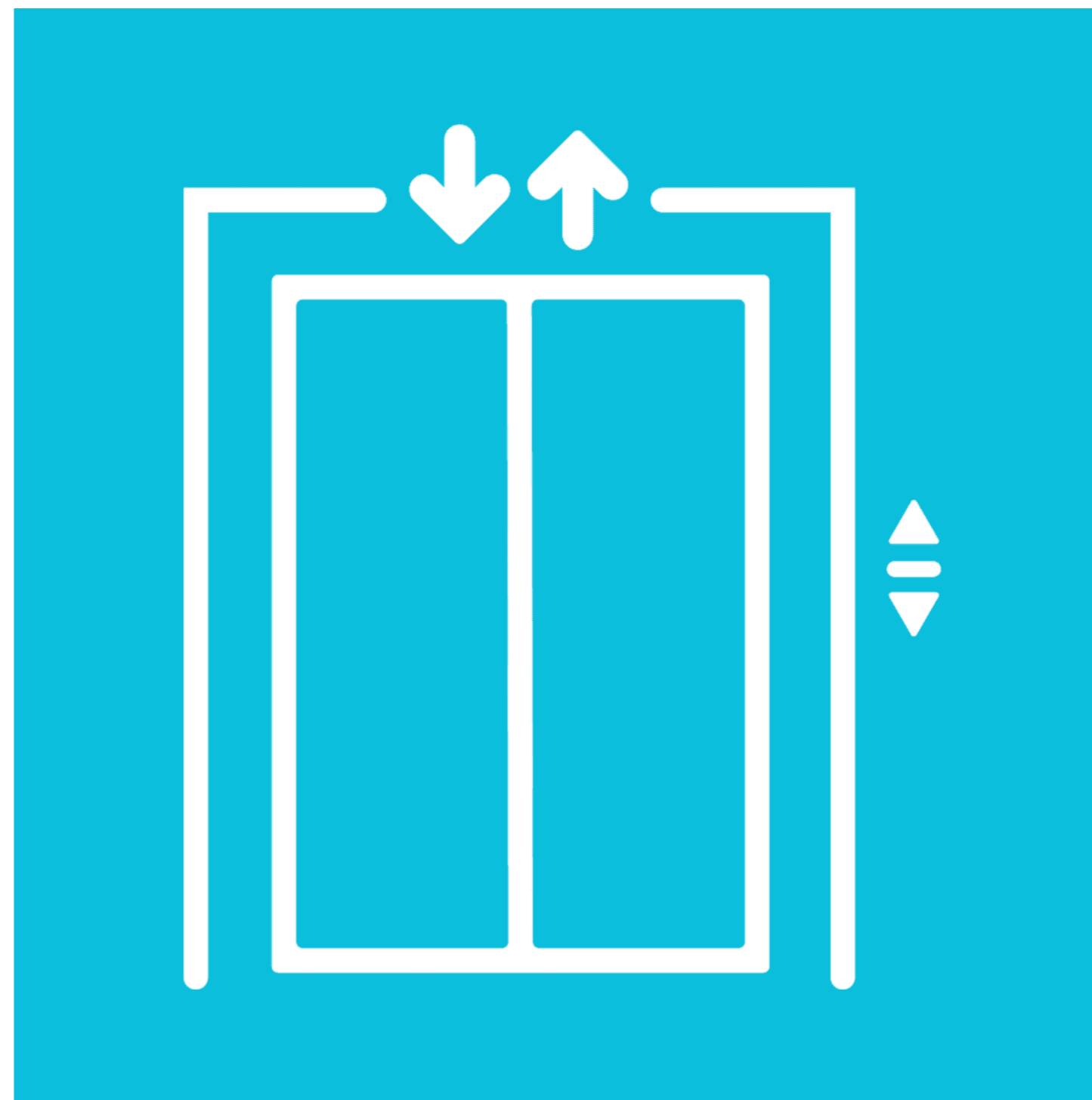
I am going in

the belt**

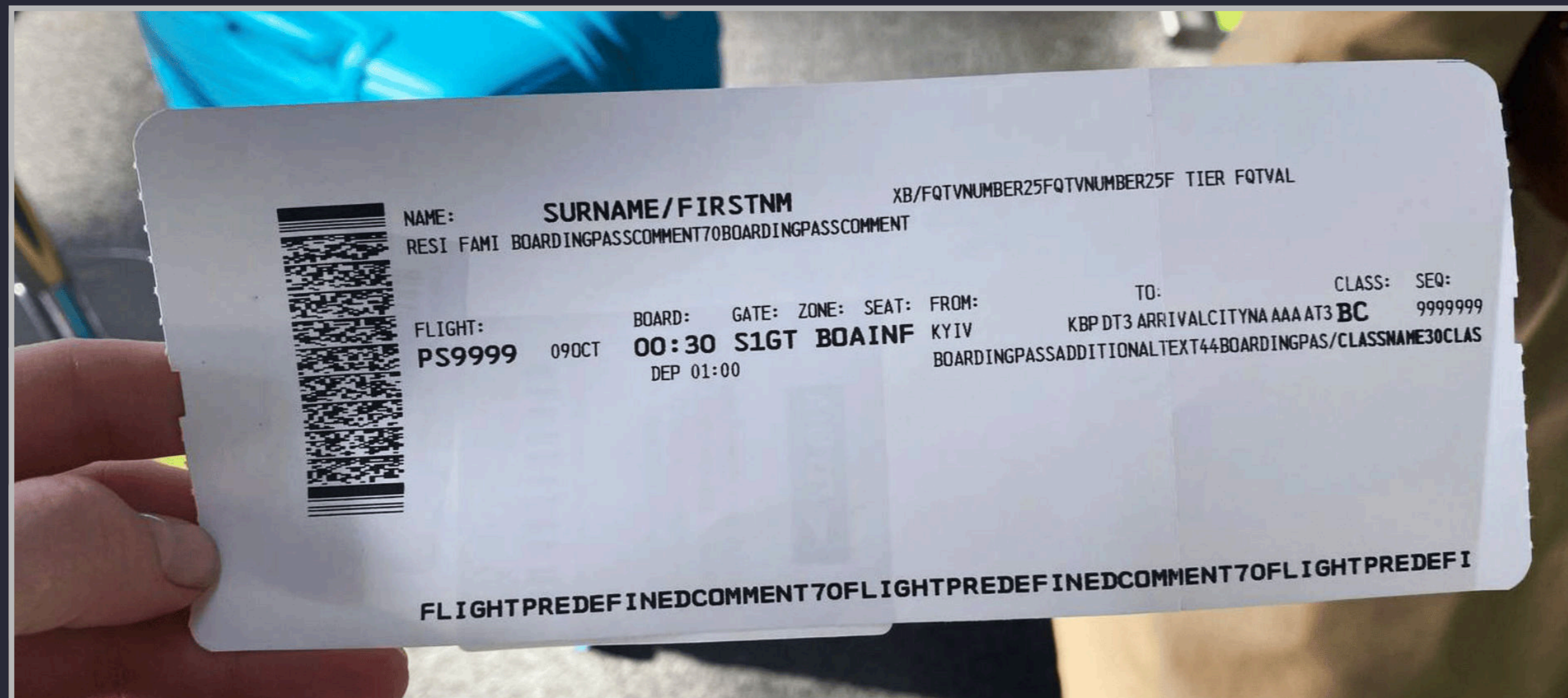
**Later it will be loaded into the

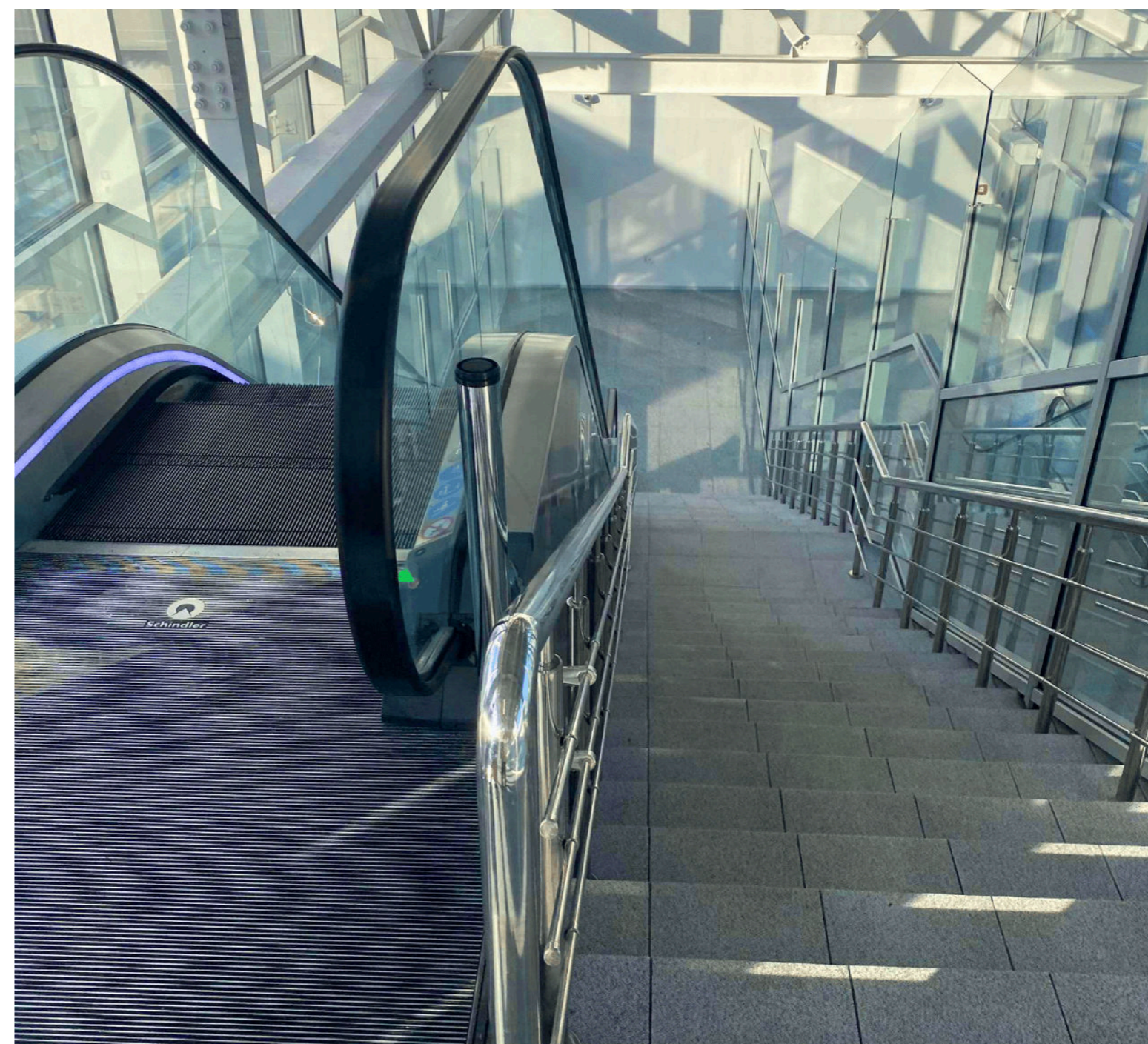
